by the Board of the College that Section 52(1)(a) is repealed and replaced by "a registration application in Form 7 including all documents required by that form".

by the Board of the College that Section 53 is repealed and the following substituted:

- 53 For the purposes of section 20(2) of the Act, a person applying for registration as a full A registrant must satisfy the registration committee that he or she
 - (a) has graduated from a recognized school of optometry,
 - (b) has passed the jurisprudence examination,
 - (c) has passed the CSAO or a CSAO equivalent,
 - (d) is a person of good character suitable for registration as a member of the college, and
 - (e) is qualified, through meeting the requirements set out in Schedule H, to prescribe, dispense and administer therapeutic pharmaceutical agents as set out in the Regulation.

f. It was resolved,

by the Board of the College that Section 54 is repealed and the following substituted:

- 54 For the purposes of section 20(2) of the Act, a person applying for registration as a full B registrant must satisfy the registration committee that he or she
 - (a) has graduated from a recognized school of optometry,
 - (b) has passed the jurisprudence examination,
 - (c) has passed the CSAO or a CSAO equivalent, and
 - (d) is a person of good character suitable for registration as a member of the college.

g. It was resolved,

by the Board of the College that Section 57 is repealed and the following substituted:

- 57 For the purposes of section 20(2) of the Act, a person applying for registration as a full registrant, and who is currently authorized to practice optometry in a recognized jurisdiction, must
 - (a) meet the requirements in section 52, and
 - (b) satisfy the registration committee that he or she
 - (i) has passed the jurisprudence examination, and
 - (ii) is a person of good character suitable for registration as a registrant of the college.

h. It was resolved,

by the Board of the College that Section 63(1) is repealed and the following substituted:

- 63 (1) A registrant seeking renewal of his or her registration must deliver to the registrar
 - (a) a registration renewal application in Form 10,
 - (b) the registration renewal fee set out in Schedule E,
 - (c) any other outstanding fee, fine, levy or debt owed to the college or to the former board of examiners under the Optometrists Act, and
 - (d) proof of completion of all applicable requirements of the quality assurance program under Part 5.

i. It was resolved,

by the Board of the College that Section 64(c) is amended by

- (a) amending subparagraph (iv) to read, "the registration fee set out in Schedule E, and"
- (b) amending subparagraph (v) to read, "(v) any other fee, fine, levy or debt owed to the college or to the former board of examiners under the Optometrists Act".
- (c) repealing subparagraph (vi).

j. It was resolved,

by the Board of the College that Section 65(2)(c) is amended by

- (a) adding the word "and" after the phrase "under the Optometrists Act," in subparagraph (vi),
- (b) repealing subparagraph (vii), and
- (c) renumbering subparagraph (viii) as subparagraph (vii).

k. It was resolved,

by the Board of the College that Section 65(3)(c) is amended by

- (a) repealing subparagraph (vii),
- (b) renumbering subparagraph (viii) as subparagraph (vii),
- (c) adding the word "and" after the phrase "member of the college," in the new subparagraph (vii), and
- (d) renumbering subparagraph (ix) as subparagraph (viii).

- (1) A corporation incorporated under the Business Corporations Act (BC) may apply to the board for a permit to carry on the business of providing optometric services to the public by delivering to the board
 - (a) a completed permit application in Form 15,
 - (b) a true copy of the corporation's certificate of incorporation, and
 - (c) a permit fee in the amount set out in Schedule E.

n. It was resolved,

by the Board of the College that Section 106(2) is repealed and the following substituted:

106 (2) A corporation applying for or granted a permit under this section must promptly advise the registrar in writing of any change to the information contained in its permit application.

o. It was resolved,

by the Board of the College that 15. Section 107 (2) is repealed and the following substituted: 107(2) A permit is valid from the date of issue shown until the next December 1.

p. It was resolved,

by the Board of the College that 16. The following section 107(3) is added: Insurance requirement

(3) A BC optometric corporation must obtain and at all times maintain professional liability insurance with a limit of liability no less than \$2,000,000 per occurrence insuring against liability arising from error, omission or negligent act of an employee of the BC optometric corporation.

by the Board of the College that Section 108(1) (a) is repealed and the following substituted:
(a) a completed permit renewal application in Form 15A

r. It was resolved,

by the Board of the College that Section 108 is amended by adding the following: 108(1)(c) All outstanding fees, levies, fines, or debt owed to the college and all renewal documents required by this Part and in Form 15A.

s. It was resolved,

by the Board of the College that Section 108 (2) is repealed and the following substituted:

107 (2) A renewal permit is in Form 16 and is valid until the next December1.

t. It was resolved,

by the Board of the College that 20. Section 108 (3) is repealed and the following substituted:

108 (3) A corporation applying for or granted a renewal of a permit under this section must promptly advise the registrar in writing of any change to the information contained in its permit application.

u. It was moved,

by the Board of the College that the following section 108 (4), (5), (6), (7), (8) are added:

- 108 (4) An optometric corporation seeking renewal of registration under this section must ensure that the documents and monies required under subsection (1) are received by the registrar on or before October 31 in each
 - (5) An optometric corporation whose documents or monies described in subsection (1) are received by the registrar in whole or in part after October 31 in a year must ensure that the late fee set out in Schedule E is received by the registrar on or before November 30 in the year.
 - (6) The registrar must renew the optometric corporation who complies with the requirements of this section and must issue to a receipt in Form 16.

Amendment to the motion:

To strike "who" and insert "that" to strike "to" and to add "16"

It was resolved by the Board of the College that,

- (6) The registrar must renew the optometric corporation that complies with the requirements of this section and must issue a receipt in Form 16(A).
 - (7) Optometric corporations renewed under this section expires on December 1 in the following year.
 - (8) A registrant whose registration is not renewed under this section on or before November 30 in a year ceases to be registered, and a new permit must be applied for under section 106.

Amendment to the motion:

To strike "A registrant" and insert "An Optometric Corporation"

It was resolved by the Board of the College that,

(8) An optometric corporation whose registration is not renewed under this section on or before November 30 in a year ceases to be registered, and a new permit must be applied for under section 106.

by the Board of the College that Section 112 is amended by striking out the words "the profession" and substituting the word "optometry."

by the Board of the College that the following fee is added to the "Fees provided for in the bylaws":
